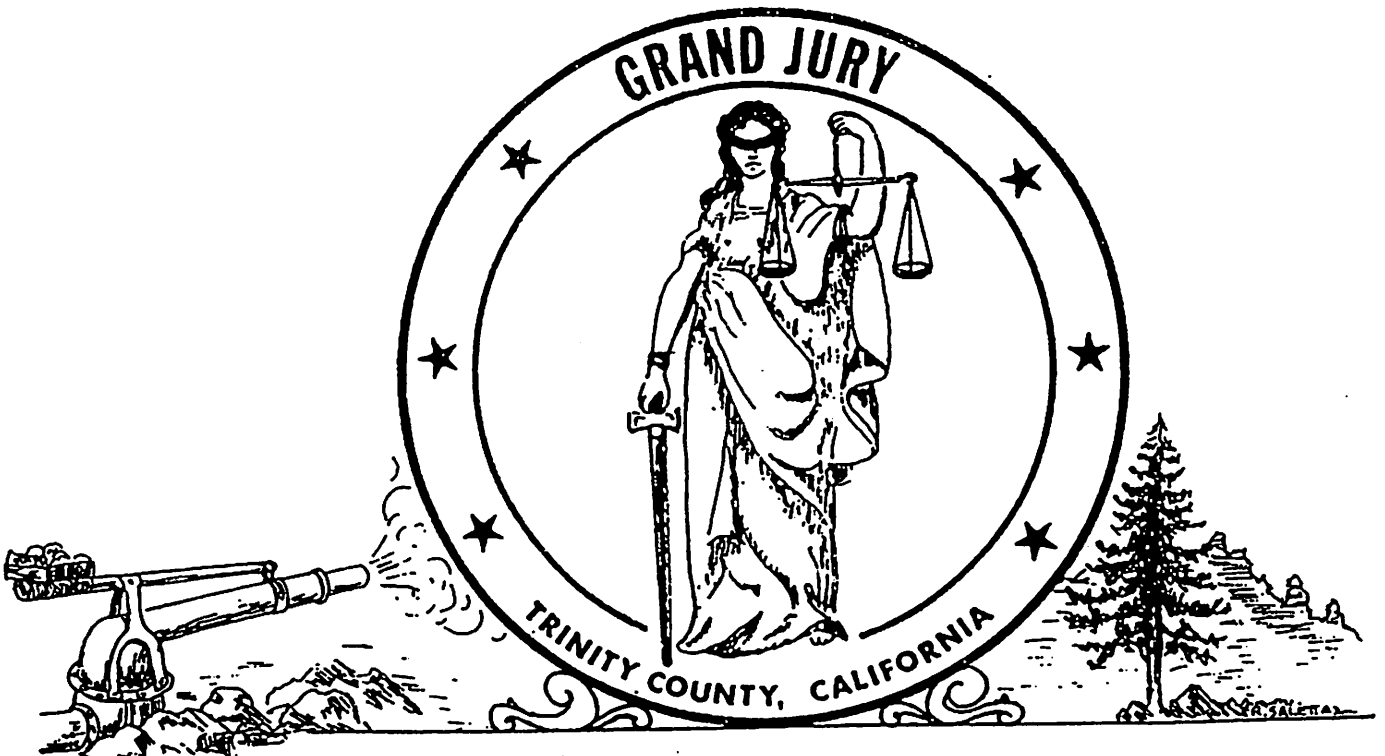

It is with a great deal of pleasure and a sense of accomplishment that the 2003—2004 Grand Jury presents its compendium of Final Reports to the citizens of Trinity County. This compendium represents the culmination of countless hours of hard work and dedication by those of us who had the privilege to serve as members of the Grand Jury.

The California Constitution requires that each county impanel a 'regular' grand jury every year. Such grand Juries have broad powers to, among other things, investigate and report upon the conduct of local government. We were impaneled on July 1, 2003 as a diverse group of 19 individuals, and given the task of coming together to form a collegial body.


The 2003—2004 Grand Jury accepted 43 Citizens Complaints and assigned those complaints to committees for review and resolution. In most cases the committees wrote and submitted their Final Reports to the full Grand Jury who thoughtfully considered and then voted a super-majority for acceptance. Our experience as grand jurors has reinforced our belief in the grand jury system. A personal note of deep appreciation to those fellow Grand Juror colleagues who gave of their time and talents to make the 2003—2004 Grand Jury a memorable experience.
